4. **Copy of Certification**

PREMIUM PROCESSING PAYMENT AGREEMENT

I am interested in being considered for an H2B visa with Sierra at Tahoe as my visa sponsor. In order to process the H2B Visa approvals in a timely manner, Sierra at Tahoe submits all applications with **5 or more people, per Consulate, to the INS (Immigration and Naturalization Service) to be Premium Processed.** I understand that the cost of this will be shared by Sierra at Tahoe, as well as each H2B visa recipient. As a condition of a Job Offer and acceptance, I hereby understand that I will be responsible to make payment to Sierra based on conditions below:

The cost of the H2B visa fee is \$300.00 and is due by August 11th, 2006.

This payment will assist with the processing fee associated with Premium Processing for H2B visas. Payments will be **tendered with appropriate authorized approval. Payments may be made with credit card, check, or money order.** All payments must be made to Sierra at Tahoe on the appropriate deadline or your space will be filled. **Cancellation notice:** Prior to the paperwork being sent to the INS you will be responsible for payment. If you choose to not join Sierra at Tahoe and the paper work has been sent to the INS you will be surrendering your fee to Sierra at Tahoe.
